Who we are

The Florida Association of Rehabilitation Facilities (Florida ARF) is the premier professional industry association for advocacy, information, and networking. Florida ARF is a leader in the initiation of public policy change to promote and protect the interests of individuals with disabilities and the community human service provider organizations, which provide them with quality services. Florida ARF members understand the power and importance of joining forces to improve the lives of citizens with disabilities. With an organized and unified public policy voice, Florida ARF strives to ensure sound public policy outcomes that protect the health and safety of individuals with disabilities.

Who we represent

As the voice of **over 100** human services provider organizations in Florida, Florida ARFs membership spans the state with members in the Northern, Central and Southern regions. With members headquartered in both Wisconsin and Indiana, several of the Association's Florida-based members operate in various states across the nation, as well. Likewise, with its RESPECT of Florida program, a service mark of Florida ARF which provides employment opportunities to people with disabilities, Florida ARFs scope reaches **64** community rehabilitation organizations, certified to participate in the program, helping to generate over **1600** jobs annually for individuals with disabilities, saving the State of Florida an estimated **\$1.1** million in taxes with the reduction of subsidies and other supports for these individuals. Moreover, the union with the Georgia Association of Training, Employment and Supports (GATES) in 1999 expanded Florida ARFs reach and influence even farther. Representing the voice of **21** community organizations in Georgia, Florida ARF is dedicated to enhancing and promoting quality programs and services for Georgia citizens with disabilities and other barriers to employment or self-sufficiency, as well.

The Industry Impact

By joining forces through association with Florida ARF our members collectively pose a considerable impact on the rehabilitation industry. Florida ARF members provide a cadre of services and supports to individuals with disabilities to facilitate improved quality of life. Our members provide services to Florida's children with disabilities age birth through 21, receiving funding to do so in part from the Department of Education, Children's Medical Services/Part C, the Department of Children and Families Developmental Disabilities program, and the Division of Vocational Rehabilitation Services. Too, many of Florida ARFs members provide an array of community supports to individuals with developmental disabilities, including adult day training, residential habilitation, respite, and personal care assistance. Our members strive to increase employment opportunities for individuals with disabilities through the provision of vital employment services, such as supported employment, job coaching, and vocational evaluation. Likewise many of our members operate Intermediate Care Facilities for the Developmentally Disabled (ICF/DD). Florida ARF members unify its legislative voice and influence through its member driven Government Relations Committee. Similarly, the Florida ARF Legal Advocacy Committee joins forces to ensure the legal rights of individuals with developmental disabilities are protected.

The Economic Impact of Florida ARF Members

Collectively, Florida ARF members paid **\$229,975,286.61** in the form of **salaries** and **benefits** to a total of **11,925** people **employed** by its organizations.

Collectively, Florida ARF members operated **programs** that **generated \$408,527,365.76** this year.

The Economic Impact of Florida ARF Members Through Service Delivery As a result of the services provided, collectively, Florida ARF members' clients earned \$44,944,249.20 from competitive and other employment arrangements.

The Industry Impact of Florida ARF Members

Collectively, Florida ARF members **provided services** to **143,444** individuals with disabilities this year:

- Placing 8,923 of those individuals into competitive employment
- Providing 26,685 with employment services
- Providing 4,365 with 24-hour residential care
- Providing 12,339 with day program services
- Providing **24,812** with **clinical services**
- Providing **31,400** with **referral services**
- Providing **40,934** with **case management services**, and
- Providing **2,909** with supported living, companion services, early intervention services, personal care, in-home supports, transportation, ICF services, respite, skilled nursing and **other services**.
